





GDPR Intent

- Update outdated 1995 Data Protection Directive
- Regulation defines the rights of EU citizens (Data Subjects) around the privacy and protection of their personal data.
- Strengthen digital economy
- **Regulations are binding**





• Controllers

A controller (eg an insurance company) determines the purposes and means of processing personal data.

• Processors

A processor (eg a service bureau) is responsible for processing or storing personal data on behalf of a controller.

• Data Subjects

Natural Persons





• Personal Data of EU Citizens

• Any information relating to an identifiable person who can be directly or indirectly identified in particular by reference to an identifier.

• Can include

Online Identifiers Location Data Name Address Credit Card Details Birthdate Photo Email Address Social Media Accounts and Posts Metadata Workplace Phone Number ID Cards and Passports Workplace or School Pseudonymous Data Genetic Data Biometric Data Medical Data





- Access (Article 15)
- Rectification (Article 16)
- Erasure (Article 17)
- Restriction of Processing (Article 18)
- Data Portability (Article 22)





- Objection (Article 21)
- Right not to be subjected to automated individual decision-making (Article 22)
- Right to lodge a complaint with a supervisory authority (Article 77)
- Right to be represented by organisations and others (Article 80)
- Right to compensation (Article 82)





Obligations - UK ICO 12 Steps

1. Awareness

You should make sure that decision makers and key people in your organisation are aware that the law is changing to the GDPR and appreciate the impact this is likely to have.




2. Information you hold

You should document what personal data you hold, where it came from and who you share it with. You may need to organise an information audit.



3. Privacy Notices

You should review your current privacy notices and put a plan in place for making any necessary changes in time for GDPR implementation.



4. Individuals' rights

You should check your procedures to ensure they cover all the rights individuals have, including how you would delete personal data or provide data electronically and in a commonly used format.



5. Subject access requests

You should update your procedures and plan how you will handle requests within the new timescales and provide any additional information.



6. Lawful basis for processing personal data

You should identify the lawful basis for your processing activity in the GDPR, document it and update your privacy notice to explain it.

7. Consent

You should review how you seek, record and manage consent and whether you need to make any changes. Refresh existing consents now if they don't meet the GDPR standard.



8. Children

You should start thinking now about whether you need to put systems in place to verify individuals' ages and to obtain parental or guardian consent for any data processing activity.



9. Data Breach

You should make sure you have the right procedures in place to detect, report and investigate a personal data breach.



7. COPs and Guidance

Review ICO's code of practice on Privacy Impact Assessments as well as the latest guidance from the Article 29 Working Party, and work out how and when to implement them in your organisation.



11. Data Protection Officer

You should designate someone to take responsibility for data protection compliance.You should consider whether you are required to formally designate aData Protection Officer.



12. International

If you carry out cross-border processing, you should determine your lead data protection supervisory authority. Article 29 Working Party guidelines will help you do this.

(1) The data subject shall have the right to obtain from the controller confirmation as to whether or not personal data concerning him or her are being processed, and, where that is the case, access to the personal data and the following information:

(2) Where personal data are transferred to a third country or to an international organisation, the data subject shall have the right to be informed of the appropriate safeguards pursuant to Article 46 relating to the transfer.

(3) The controller shall provide a copy of the personal data undergoing processing. For any further copies requested by the data subject, the controller may charge a reasonable fee based on administrative costs. ³Where the data subject makes the request by electronic means, and unless otherwise requested by the data subject, the information shall be provided in a commonly used electronic form.

 (4) The right to obtain a copy referred to in paragraph 3 shall not adversely affect the rights and freedoms of others.







On 23 June last year, the people of the United Kingdom voted to leave the European Union. As I have said before, that decision was no rejection of the values we share as fellow Europeans. Nor was it an attempt to do harm to the European Union or any of the remaining member states. On the contrary, the United Kingdom wants the European Union to succeed and prosper. Instead, the referendum was a vote to restore, as we see it, our national self-determination. We are leaving the European Union, but we are not leaving Europe – and we want to remain committed partners and allies to our friends across the continent.

Earlier this month, the United Kingdom Parliament confirmed the result of the referendum by voting with clear and convincing majorities in both of its Houses for the European Union (Notification of Withdrawal) Bill. The Bill was passed by Parliament on 13 March and it received Royal Assent from Her Majesty





Article 32 – Security of Processing

"...the controller and the processor shall implement appropriate technical and organisational measures to ensure a level of security appropriate to the risk...."


